Individuals and families that attended received provider information, enjoyed activities and good food. The Awareness Committee is reviewing feedback from the event to plan for next year's event.

  Corso). Ms. Beier has scheduled to meet with Mr. Pete Daniels and County Commissioner Mr. Bill
  Monaghan to tour the ECBDD facilities on July 29<sup>th</sup> at 3:30 pm.
- The Erie County Board of DD will be hosting a parent networking meeting with DODD Parent Advocate, Peggy Martin on August 27<sup>th</sup> at 5:30 pm. Ms. Martin will be sharing information about Parent Networking Opportunities, Family Chat, Family Advocacy and Employment First Initiative.
- A Community Connections staff member, (SSA) Service and Support Administrator and (EI) Early Intervention staff member will all be attending Community Connections Trainings sponsored by the Clearwater COG. This is a series of trainings to promote Self Determination, Community Connections and Self Advocacy. The COG has brought in 2 trainers who are experts in the area of integration and long term community connectedness.
