I.CALL TO ORDER AND ROLL CALL: 5:01 p.m.

II. PLEDGE OF ALLEGIANCE

III. PUBLIC COMMENT

- A. Jim Meade reminded Board members about the Art Show downtown as well as the Erie County Self-Advocacy group which meets monthly on the 1st Monday at 4:30 at the Board facility.
- B. Megan Etzel introduced Lori Wilken, a new SSA for children ages 3-12.

IV. APPROVAL OF MEETING MINUTES

Mr. Howard Collins made a motion to approve the March 17, 2016 Board Meeting minutes. Mr. Bob Wright seconded the motion, with all members in favor, the motion passed.

V. ANNUAL PLAN/DEPARTMENT REPORT

<u>A. Strategic Plan – Carrie Beier discussed the handout detailing the progress thus far with the Board's Strategic Plan.</u> A DRAFT data report was also discussed which will be presented again at the August meeting. Eric Kibler recommended that the 4 career paths are defined and included in the section "Numbers of individuals on the path to employment". Board members were asked to review and provide feedback to Carrie. Data will be lined up by quarters.

VII. BOARD ACTION ITEMS

- A. Ethics Committee- did not meet
- B. <u>Finance-</u>
 - Finance Committee Report- The Finance Committee met and reported that the budget has been approved. No news has been received from OPERS. Revenues appear a little high due to first of two county tax allotments received. Expenditures are currently running slightly below budgeted amounts.

2. <u>Acceptance of January Financial Report</u>- Mr. Jude Theibert made a motion to approve the March 2016 Finance Report. Ms. Stacie Schmid seconded the motion, with all members in favor, the motion passed.

VIII. OLD BUSINESS

A. Policy Review-

 Personnel Policies Sections 300 & 400 Ms. Stacie Schmid reported the Board's feedback and some minor formatting changes were made. Mr. Howard Collins made a motion to approve the Personnel Policies 300 & 400 as written. Mr. Don Sieg seconded the motion and, with all members in favor, the motion passed.

IX. NEW BUSINESS

- A. <u>DRO Lawsuit</u>- Carrie Beier discussed the lawsuit from Disability Rights of Ohio (DRO) which was sent to Board members. No specific county boards were named in the lawsuit unless they operate an Intermediate Care Facility for the Mentally Retarded (ICFMR). This is a class action lawsuit and it is expected to be a very long process the outcome of which will be determined by a judge.
- B. <u>COG Provider Development</u>- This is a new position titled "Provider Relationship and Recruitment Specialist" focusing on individual provider recruitment in the 8-county COG region.
- C. <u>Shared Living- This residential option is paid for through an Individual Options (IO) Waiver where a non-related provider opens their home to an eligible individual. The provider is paid a per diem rate based on a completed Developmental Disabilities Profile (DDP). Carrie Beier will show a couple of videos about Shared Living at the next Board meeting.</u>

X. Superintendent Report

The Superintendent reported on various events and initiatives happening at the Board.

 State Board of Trustee Meeting, Superintendent Executive Committee Meeting, Erie County DD
 Family Information meeting, Region 1 Superintendent meeting, Clearwater COG Board meeting,
 Erie Co. Bd. DD Night to Shine and Erie County Chamber of Commerce Business Expo.
- There has been no confirmation yet from the Federal Centers for Medicare and Medicaid (CMS)
 regarding the approval of Ohio's State Transition Plan. Director Martin states Ohio is
 continuing conversations with CMS and the Department will keep local county boards
 informed.
- The Ohio Association of County Boards of Developmental Disabilities will be developing a pilot training program for possible use statewide addressing abuse and neglect prevention. The

project will be a collaborative effort between local law enforcement and county boards with an emphasis on techniques and practices to support victims and how to best collaborate between agencies supporting individuals with DD who may have experienced abuse or neglect. Summit and Stark County Boards of DD will be the first counties to pilot the program.

- We are contracting with Ms. Michelle Marcellus (an individual we serve) to assist the County
 Board in our efforts to enhance some of our internal processes and practices. Ms. Marcellus is
 a 2005 graduate of Kent State University with a Bachelor degree in Human Development and
 Family Studies. She will provide consulting services for the Board regarding advocacy, local
 hiring processes, orientation content, newsletter article development and policy review.
- Attached you will find a copy of the "Thank You" note from Erie County Special Olympics for the Board Donation.
- Attached you will find a copy of the first edition of Clearwater COG <u>Community Connections</u>
 <u>Communique</u> Newsletter. Diane Corso is featured in this edition in the Spotlight section. We
 are proud to have Diane and the Erie County Community Engagement Department recognized
 for the great work they are doing and the opportunities they are developing for those we serve.

- In May and September this year we are offering to our staff a Self Defense Training. This
 training, taught by Greg Hall of North Coast Tactical Training Academy, and participation is
