BOARD MEETING MINUTES APRIL 19, 2018

I. CALL TO ORDER AND ROLL CALL

The April 19, 2018 Board Meeting was called to order at 5:00 p.m. by President, David Stuck. Roll Call was taken. Mr. Don Sieg was absent excused with all other members present.

III. PUBLIC COMMENT

B. Finance Committee:

1. Finance Committee Report

The Finance Committee did meet. Rachel Malone reported the following on behalf of the Finance Committee:

- 1st half taxes received as well as a MAC payment.
- The 2016 fiscal reconciliation for self-waivers is higher than normal. DODD withheld more for state funding than was necessary and therefore, counties' reconciliation amounts were higher than previous years.
- Expenses Taxes paid to the Auditor for Levy collection. Additional information will be gathered regarding these taxes paid to the Auditor for collection of our levy (i.e. standardized rate, do all counties pay, etc.).

2. Fiscal Report

The Fiscal Report for Month End March 31, 2018 was distributed for review and approval (attachment). Mr. Howard Collins made a motion to approve the March Fiscal Report as submitted. Mr. John Hoty seconded the motion. With all members in favor the motion passed.

- 3. Financial Then & Now Resolution
 - a. Payment to Erie County Commissioners Resolution # 04-05-2018

The Erie County Commissioners require a Board THEN and NOW resolution for expenses exceeding \$5,000.00 that are being submitted for payment without a previously encumbered purchase order. This THEN and NOW resolution confirms that the DD Board had insufficient money in the budget at year end 2016 (THEN) and also has sufficient money in the expense line item in 2018 (NOW) to pay this invoice. The resolution authorizes payment to ERIE COUNTY COMMISSIONERS (inv #2018CAP-20110) for INDIRECT COSTS ALLOCATED FOR YEAR 2016 PAYABLE IN YEAR 2018 services in the amount of \$15,220.66 (Fifteen Thousand, Two Hundred and Twenty Dollars and 66/100 Cents).
