B. Waiver Modernization Update/ Stop Loss Proposal

A handout was provided to Board Members on the DODD Waiver Modernization Project (handout). Carrie Beier reported that Rachel Malone is part of the County Board Workgroup that has been meeting to discuss DODD and County Board waiver funding, and proposed reimbursement system changes. Rachel shared details on the Stop Loss Proposal, which includes factors such as: eligibility, reserved funds, and match cost. The Stop Loss Proposal would be similar to an insurance program for high cost waivers, with a capped amount that local county boards would be responsible to match. We will continue to keep Board Members informed as updates occur.

Accreditation:

We received one citation regarding the process for addressing behavior supports when a restriction needs to be a part of a person's supports. We have submitted our Plan of Correction (POC) and the team has met to discuss a plan to move forward. Attached you will find the email from Tina Haggerty, the lead reviewer for DODD's accreditation team. Carrie shared that she is extremely proud of all staff who work to support the lives of those we serve.

OACB - Legislative updates:

 House Bill 512: Representative Gail Pavliga (R-Portage County) introduced House Bill 512, aiming to create a more efficient licensing process for emergency placement facilities catering to children with developmental or intellectual challenges and high acuity behaviors. The bill is currently under review by the House Families and Aging Committee.

Recently, the committee held a proponent testimony hearing, during which advocates for the bill presented their arguments in favor of its passage. This progress signifies a step forward in addressing the urgent need for appropriate housing and support for children in need.

Key aspects of House Bill 512 include:

- Streamlined Licensing Process: The bill proposes a more efficient process for licensing emergency placement facilities for children, which would help to address the immediate needs of children entering the system.
- Collaboration for Solutions: The Ohio Family and Children First Cabinet Council would be required to collaborate with stakeholders, including county boards and DODD to develop treatment and placement solutions for children with developmental or intellectual challenges.

During the proponent testimony hearing, the Public Children's Services Association of Ohio (PCSAO) presented survey data indicating that 1 in 4 children enter the children services system due to mental health issues, developmental/intellectual disabilities, or from juvenile custody facilities. This has led to an increase in the number of children awaiting placement, while the number of acceptable housing opportunities has declined. PCSAO testified that House Bill 512 would provide short-term placement opportunities for children with complex needs while long-term housing options are being identified.

Written testimony in support of the bill was also submitted by the County Commissioners Association of Ohio (CCAO), Portage County Department of Jobs and Family Services, and Ohio Children's Hospital Association. The bill now awaits future committee consideration and hearings.

- **Dept. of Justice Update:** New Voting Guidance for those with disabilities. Key points of the new guidance include:
 - 1. Voter Registration and Poll Access: People with disabilities have the right to register to vote and access polling places and voting systems without facing discrimination.
 - 2. Assistance in Voting: Voters with disabilities can receive assistance from a person of their choice. This includes help with requesting, completing, and returning ballots, whether voting in person, absentee, or by mail.
 - 3. No Stricter Standards: States are prohibited from imposing stricter standards on people with disabilities, including those under quardianship.

Service Animals and Accessible Methods: Polling places must allow

service animals and offer accessible voting methods to ensure that people with disabilities can vote independently and privately.

• FFA Reauthorization Act introduces air travel improvements for those with disabilities: The recent signing of the Federal Aviation Administration (FAA) Reauthorization Act brings significant improvements for travelers with disabilities. This new law introduces several measures aimed at enhancing the air travel experience for passengers with disabilities by addressing various aspects of their journey from booking to landing:



- Accessible Seating Accommodations:
 Passengers will now have the ability to request more leg room or seating closer to restrooms, ensuring a more comfortable flight experience.
- Onboard Wheelchair Reservations: The Act mandates that airlines provide clear information about the ability to reserve onboard wheelchairs, making it easier for passengers who need them.
- o **Improved Training for Airline Workers:** Airline staff who assist passengers using wheelchairs will receive better training, ensuring they can provide the best possible support and assistance.
- Universal Changing Stations: All medium and large airports are now required to install or maintain at least one universal changing station in every terminal. This includes appropriate signage to guide users to these facilities.
- Enhanced Accessibility of Digital Platforms: Airline websites, apps, and kiosks must increase their accessibility, making it easier for passengers with disabilities to navigate and use these resources.
- DODD: 25th Anniversary of Olmstead V. L.C.: On June 22, 1999, the Court issued an opinion pursuant to the Americans with Disability Act, finding that individuals with disabilities should receive services in the most integrated settings possible. Since that finding, the Centers for Medicare and Medicaid's Money Follows the Person program (known as HOME Choice in Ohio) and DODD's various Incentive Programs, including Exit Waivers, Transition Funds, Bridge Funding, Community Capital Assistance, and the Rental Assistance Program, have made it possible for many Ohioans with developmental disabilities to transition to the community.
